Any V5.1 update applications submitted after April 15 will be temporarily delisted on June 30 while the review of the application is completed. Manufacturers are encouraged to submit before the April 15 deadline to ensure that there is no disruption to their listed products.



Reminders About the Old Application Portal

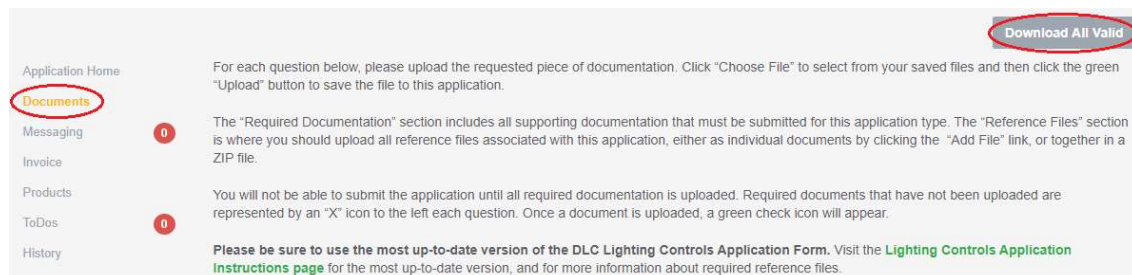
Completing Applications in the Old Application Portal

Any applications in process in the old application portal must be completed by May 1 or they will need to be resubmitted in the new application portal using a new application.

Downloading Application Documents from the OLD Application portal

To download all documents from a single application:

1. Go into the application
2. Select "Documents" from the left hand menu of the application
3. Click "Download All Valid" from the upper right hand corner of the application

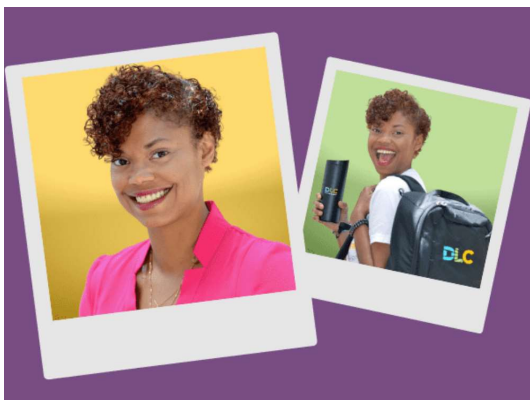
